**ORDINANCE NO. 18-03**

**AN ORDINANCE REGULATING WAGES OF LABORERS, MECHANICS AND OTHER WORKERS IN ANY PUBLIC WORKS BY THE VILLAGE OF CHEBANSE**

**WHEREAS**, the State of Illinois has enacted the Prevailing Wage Act 820 ILCS 130/1 et seq.; and,

**WHEREAS**, the aforesaid Act requires that the Village of Chebanse, Iroquois and Kankakee Counties, Illinois investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics and other workers in the locality of said Village of Chebanse, Iroquois and Kankakee Counties, Illinois employed in performing construction of public works for said Village of Chebanse.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHEBANSE, KANKAKEE AND IROQUOIS COUNTIES, ILLINOIS AS FOLLOWS:**

**SECTION ONE:** To the extent and as required by "An Act regulating wages of laborers, mechanics and other workers employed in any public works by State, county, city or any public body or any political subdivision or by anyone under contract for public works," approved June 26, 1941, as amended, the general prevailing rate of wages in its locality for laborers, mechanics and other works engaged in construction of public works coming under the jurisdiction of the Village of Chebanse is hereby ascertained to be the same as the prevailing rate of wages for construction works in the Iroquois and Kankakee Counties, Illinois area as determined by the Department of Labor of the State of Illinois as of June of the current year, a copy of those determinations being attached hereto and incorporated herein by reference. As required by said Act, any and all revisions of the prevailing rate of wages by the Department of Labor of the State of Illinois shall supersede the Department's June determination and apply to any and all public works construction undertaken by the Village of Chebanse. The definition of any terms appearing in this Ordinance which are also used in the aforesaid Act shall be the same as in said act.

**SECTION TWO:** In the event IDOL adopts different prevailing wage rates after the Effective Date of this Ordinance, a copy of those rates will replace the June 2017 rates attached to this Ordinance and be automatically incorporated into and, by this reference, made a part of this Ordinance as Exhibit A without any further action of the Corporate Authorities.

**SECTION THREE:** Nothing herein contained shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works construction of the Village of Chebanse to the extent required by the aforesaid Act.

**SECTION FOUR:** The Clerk of the Village of Chebanse shall publicly post or keep available for inspection by any interested party in the main office of the Village of Chebanse this determination of any revisions of such prevailing rate of wages. A copy of this determination or

of the current revised determination of prevailing rate of wages then in effect shall be attached to all contract specifications.

**SECTION FIVE:** The Clerk of the Village of Chebanse shall mail a copy of this determination to any employer and to any association of employers and to any person or association of employees who have filed their names and address, requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

**SECTION SIX:** The Clerk of the Village of Chebanse shall promptly file a certified copy of this Ordinance with the Department of Labor of the State of Illinois.

**SECTION SEVEN:** All existing ordinances of the Village of Chebanse are hereby repealed insofar as they may be inconsistent with the provisions of this ordinance.

**SECTION EIGHT:** This Ordinance shall be in effect from and after its passage, approval and publication in pamphlet form.




